Eligibility to compete: A complete entry form including instructor approval, as required, a current USJI, USJF, or USJA membership card MUST be presented at registration, along with the LIABILITY WAIVER and ENTRY FEE. There will be no refunds of the entry fee.

Contest Rules: Current IJF contest rules will govern EXCEPT no chokes or arm locks for 12 years old and younger. No arm locks for ages 13 to 16 years old. Any judoka under the age of 16 who wishes to compete in a Senior division will compete with no exceptions to the IJF rules. Anyone competing up in rank divisions will be subject to the rules for that group. Any attempt to perform any technique with the intent to injure the opponent as determined by the officials on the mat will be an automatic hansoku make. The CARE System will be used based on availability of the CARE equipment. The competition area is 6m x 6m with 3m of safety around the mat edge and 4m of safety between mats. All competitors should have two gis, one blue and one white. If you only have a white gi, then you should have a blue belt and a white belt of your own. You cannot come with only a blue gi.

Elimination System: Round Robin for small divisions. Larger divisions will use a modified Double elimination System will be used. The winner of the winner's pool shall get first place, the winner of the loser pool shall get second place and the loser of the final match in the loser pool shall get third place. For divisions with fewer than 5 contestants, a round robin point system will be used.

Divisions

Kata: Novice - Nage No Kata (3 sets) Advanced - Nage No Kata (5 sets)

Novice – Open Kata Advanced – Open Kata

Novice division will be considered all Junior ranks and Senior ranks below Sankyu. Sankyu and above will be considered Advanced. Mixed teams will be ranked off of the highest level player. In the Open Kata division, any kata can be performed. There are not separate divisions for each kata.

Junior Boys: All divisions will be divided into light, medium and heavy (additional divisions may be added)

Junior Girls: The number of divisions will depend on the number of registered contestants

Judoka 30 years and older may compete in the Masters division.

1. Female competitors are REQUIRED to wear a plain white tee shirt.

- 2. All competitors should have two gis, one blue and one white. If you only have a white gi, then you should have a blue belt and a white belt of your own. You cannot come with only a blue gi.
- 3. The tournament director reserves the right to alter or change any division to establish a more equitable competitive division. Any changes will be discussed with the coaches and/or the competitors involved prior to the actual change. There will be no single winner of a division.

<u>Awards</u>: Awards for first, second and third places. Trophies for Junior Team and Senior Team (by points based on 5 pts for 1st, 3 pts for 2nd and 1 pt for 3rd). Trophies for Outstanding Junior and Outstanding Senior.
