Round Robin Pairing	All competitors in the age grouping will line up by weight (per age group in the schedule). The tournament director (with input from the attending head coaches) will adjust line-up and create 4 person round robin divisions. Adjusting the line-up may include, but is not limited to: 1. Pairing novice players together 2. Pairing judoka from different clubs 3. Pairing female players with other female players. Once a round robin pairing is set, they will go to their mat assignment for competition. 4 man round robins consist of 3 rounds (3 matches per contestant). Some round robins may be limited to 2 or 3 players based on weight limitations (20% of the competitor's weight). Awards will be presented at the conclusion of the round robin. Contestants may fight up in age group for their second division. Criteria for the winners will be: 1. Wins/Losses. 2. Points 3. Head to Head matches.

Rules	Must be a current USA Judo, USJF, USJA, AJJF or ATJA members. Current modified IJF rules will govern the tournament. No shime-waza for age 12 and under. No kansetsu-waza for age 14 and under. There may be Co-ed competition for 8 and under. The CARE System will be used based on availability of the CARE equipment. Loss of consciousness or signs of concussion will result in removal from any and all divisions at the event. Contestants are required to bring either a blue gi or a blue belt for blue matches AND a white gi with a white belt for the white matches. A white gi is required by all judoka, if you are assigned to white and you only have a blue gi then you will forfeit the match. A white gi with a blue belt is satisfactory for matches when assigned the blue color.
