Information:

Participation in this examination and shiai is limited to judokas of junior rank only. All judoka must be a current member of the USJF, USA Judo, or USJA. Judoka that do not mail in a copy of their membership card with their entry form must present their membership card at the time of registration. There will be an opportunity to register with USJF at the tournament site. All participants must be listed on the "Judoka recommendation for promotion" form that is submitted by the sensei of each club. Only judoka listed on the forms with ALL required documentation will be considered for promotion, ONLY USJF members will be promoted. USJA and USJI members may request to be examined and have their results from their participation forwarded to the appropriate organization for consideration of promotion. Contest Evaluation and rules:

There will be NO kohaku shiai. All judoka be examined will be evaluated in a contest setting, unless the judoka is being examined as a non-competitor. Modified IJF Rules will govern this tournament. The head table must be informed if any judoka is not participating in any part of the shiai. No shime waza (chokes) for Juniors age 12 and under, and there will be no kansetsu waza (armbars) allowed in Junior competition. Those who perform prohibited acts are subject to automatic Hansoku Make. Any Junior that participates in Senior Competition on Sunday is subject to the Senior tournament rules. Contest participants will be matched by Age, Rank, and Weight.

Awards:

There will be an **Outstanding Judoka Award** presented to a selected junior participant at the end of the day. Criteria for this award will be based on a combination high scores on the individual evaluation and examination scores, demonstration of judo spirit, how well the contestant performed during the examination, the quality of the waza executed during shiai, the quantity and quality of wins, and the rank of their opponents.

Eligibility:

Examinees must meet the established *Shufu Judo Yudanshakai* promotional requirements and be recommended by their instructor for promotion. Examinees are expected to have met the following promotional requirements before examination to higher rank:

- Minimum age
- Time in grade

Documentation Required for Promotion:

- Submit a promotional packet to your instructor including:
 1. Entry form, signed waiver, and Shufu entry/examination fee.
 2. A photocopy of your current USJF membership card or USJF membership application with fees

Note: Judoka MUST be listed on the “Judoka recommended for promotion” form from the sensei. All judoka may apply for USJF membership on site.

Deadline for Paperwork: Paperwork must be postmarked by Wednesday, March 17, 2010. There will be NO ON SITE REGISTRATION. All documents must be submitted through your instructor, checked and verified for accuracy and mailed in a timely manner to:
